Sunday and Monday doesn't work for most people. 150.00 is the suggested fee for 2 days..

There were only 2 people who showed an interest in this workshop mostly due to the timing.

Guest member asked if there could be another day for Ingrid Christianson since her workshop is filled and it has a waiting list.

Dennis Weber spoke about having accredited artists teach workshops and how much you can learn from a professional artist.

June 1st is Artwalk deadline - FCA Juried show - need to notify members, need 1 SFCA and 2 AFCA to jury the show.

There were questions about the membership process for active, AFCA and SFCA. Dennis Weber spoke about the AFCA and SFCA status and how you obtain signature status and how the SFCA jury process has 25 people looking at the art work.

Three of the Executive want to go to the AGM in Vancouver, April 16th and return on the 17th. Sheila - would like to find out about the on line process, Barb wants to improve the executive positions and be able to encourage members to get involved, Patti has lots of questions on how to make our chapter stronger.

Proposal the Kelowna Chapter pay for travel and hotel in Vancouver. Dennis made a motion to approve the costs of the executive travel expenses to Vancouver, a budget of \$500.00, Motion seconded by Kit Bell. Approved by a show of hands.
